b. <u>TERMS OF CONTRACT.</u> Contracts awarded Pursuant to NJSA 40A:11-4. (2) may be for a term not to exceed <u>five (5) years.</u>

The award of this contract shall be for an initial period of two (2) years with three (3) separate one-year options to renew the contract at the sole discretion of the Township.

The Township may terminate the contract for convenience by providing 60 calendar days advance written notice to the Vendor.

The price provided in the proposal shall remain firm for the duration of the contract.

COST PROPOSAL AND PRICING

A "not to exceed" amount shall be established by the Township and shall apply for the term of the contract. The amount is intended to be use as estimate of the appropriated funds for the retention of services, which shall be amended, depending on the needs and actual work ordered and completed. The vendor will be paid only for the actual work provided and completed. The vendor shall notify the Township when seventy percent (70%) of the "not to exceed" amount has been expended. The contract amount must be amended by resolution, otherwise, the vendor must stop all work until the amendment is approved by the governing body.
